A story I have to tell....but brings a lot of pain.

There is one specific day in the Sea Org I remember all to well. A day that I allowed Sea Org executives to push me into forgetting my own integrity, beliefs, maternal instincts and honor. A day that will forever burn in my memories as one of the times I walked a VERY dark path down the unknown evil of the Sea Org that was the oracle of hidden truths, lies and deceat.

THIS IS NOT AN EASY READ AND SHOULD NOT BE READ BY THOSE WITH A WEAK STOMACH OR VERY EMOTIONAL PERSON AS IT MAY PRODUCE A VERY NEGATIVE EFFECT - EMOTIONALLY.

After my 2 forced abortions, pushed by the execs at my org and my husband, almost 2 years apart (I was on the pill, but my husband and I had agreed that we would one day want a family and would figure things out from there, there was a very young married girl(about 15), who was Sea Org at my org. She was "creating a flap because not only was she pregnant, she was ACTUALLY considering having "IT"."

Now, just to take you back a bit and give you some backround

who pushed so intensely on my abortions. She told me a story that I think she thought would help me feel better (NOT). Here is her story which is very vague from my memory but the details are basically the same.. She was pregnant about 5 years prior, but because her menstation was very irregular to begin with, she didn't find out that she was pregnant until she was about 14 weeks (I may be off, but it was enough where she had to deliver - they couldnt just vaccum the remains). She was a an RTC level org (the highest you can go in Sea Org mngmnt) and it was under no circumstances ok to consider having children). A Scientology MD was found that would perform the illegal abortion as at that stage, the fetus had a heart beat and was formed. The MD inserted a very long needle of some sort to the cranium of the fetus, through her sac and then stimulated her to go into labor. She delivered the fetus, which basically came out in several peices for what ever reason. After seeing this and being through this, she was back to work the next day as expected by the executives of her org. This was one of the things told to be before my first abortion as a way to show me that it can be done and that "people recover from it". I was ordered to convince the young girl I spoke of above, to have an abortion. I was to take her someplace neutral and convince her that her having an abortion was for the "Greatest Good for the Greatest Number of Dynamics". That is was the best thing for her to do. I was to get a "DONE" on this and send her back to HCO to work out the logistics.

I really didn't want to do this, but I was in lower conditions for having doubts on the Sea Org (once again and was talked/guilted/threatened into staying once again and was "coming up through the conditions", and this was one of the things I had to do to prove that I was part of the group.

I took her to Griffith Park, on a beautiful day with flowers in bloom.

The suns rays were seeping through the overhanging leaves of a tree, above the bench I choose for us to sit at.

I had the worst feeling in my stomach and was very nauseous. But, I proceeded to talk to her (I was told to do it as I knew what she was going through and I was young, not younger, and she may listen to me).

Just because of who I was, under all of the grease and grime, I tried to make her feel as comfortable as possible and didn't use any force at all. But I went over the dynamics, the purpose of the Sea Org, the importance of the Sea Org. I also spoke about the world and the crime and all of the horrible things her child would be subjected to. I spoke about the responsibility and used her young age as well as her husbands (16) to show how it just could be for the best. Although I did all that - I went off the record and told her about how I felt when I went through it - exactly to the very detail of what occured and what the dr's would do. I went over my emotional and physical state and why I was out of work for 7 days after (I got so sick and I was in such turmoil and a world of anger and sadness that I couldnt get out of bed). I told her that children are the greatest gifts women young and old could ever have, but that it did take responsibility and commitment. I made sure she knew that I wanted her to form her own decision despite what I have said and that I was ordered to tell her everything I told her before I got personal. I tried to sway her in a way that it wouldn't seem like I was swaying her as I was going to be 'meter checked' afterwards and if it was found out that I swayed her -I would be in deep %#@\$.

I hoped that after I took most of our time trying to get her disabused of the idea that being pregnant was an 'overt' and that she was 'outethics' and all of the things that she was accused of for being pregnant - that she would keep the baby and leave as I told her about that option and what she would have to do. When we finished and drove back to the org in silence, HCO personell were waiting for us. They took me in and I told them all of the things I said to her (without telling the personal stuff I spoke about and my intention) and then they took her in. I only remember that she was in with HCO and the HAS (the story I told you earlier) for a very long time and I saw her leave the office in tears.

But I found out days later, that she did get the abortion. I walked around in a daze - I felt so guilty and responsible. To this day I think about the future that could have been. The joy that could have been and the little innocent, whose life was sacrificed yet again - for the good of the Sea Org.

Now that I have taken you into the depths of sadness, there is some

good news that I heard through the grape vine a few years back. She divorced her husband and married another (married 2x and younger than 20) and she got pregnant again and this time she routed out of the Sea Org and had the baby. I have to run, but I will be back to answer any questions.

Thank you for giving me the opportunity to get these things off of my chest - they have been hidden away and known only by those executives involved and a few suspecting staff members and of course the young girl who will go unnamed.

Now you may understand why I am also known as "Still Not Free", because it is things such as those above that hover over my heart, going unforgiven from self.
