CAMPAIGN TREASURER APPOINTED BY CANDIDATE: May be appointed to receive but not to disburse moneys to aid or promote the success of such candidate (P.A. 75-571, Section 13; Sec. 9-348b, C.G.S.).

BANK DEPOSITORY: A bank depository for campaign funds must be designated for each Principal Campaign Treasurer of a candidate in connection with any primaries or elections for state, district, or municipal offices.

(*Chairperson of committee signs form.*)

BANK DEPOSITORY: A bank depository for campaign funds must be designated for each Campaign Treasurer of a political committee, continuing political committee, organization political committee, or political issue committee in connection with any primaries, elections, or referenda.
